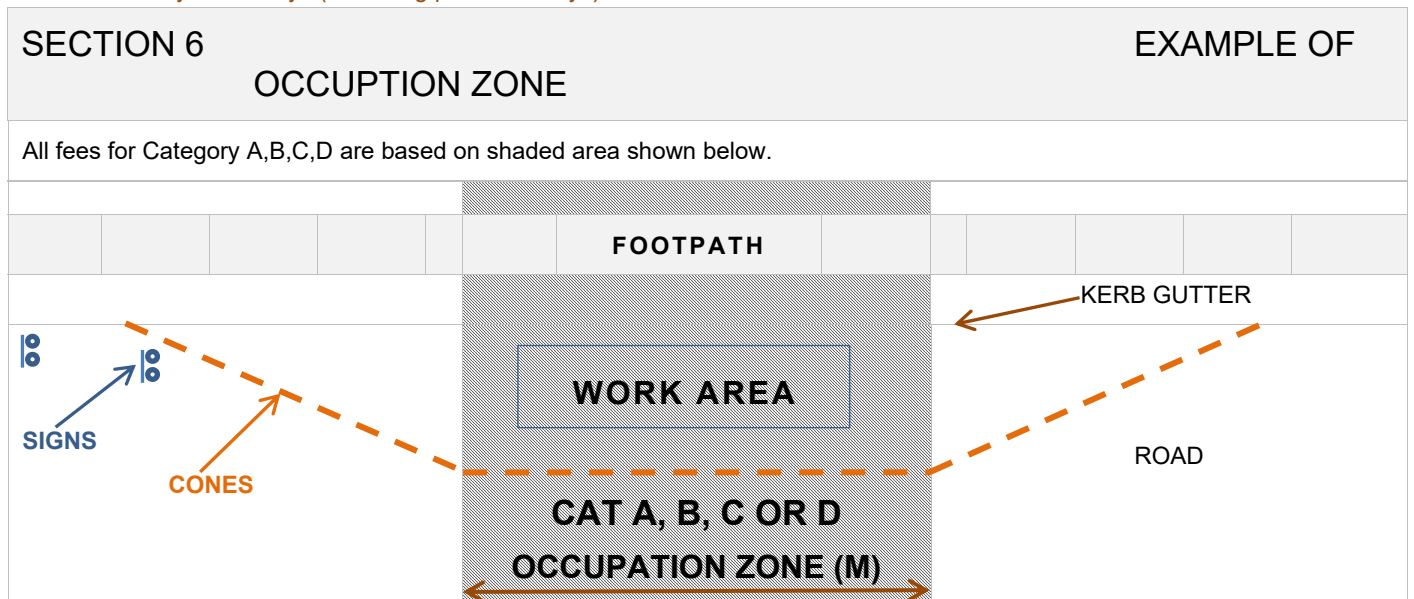

It must be prepared by a qualified person with Level 4 Certification in Traffic Control, with their name and ticket number clearly marked on the plan.</p> <p><input type="checkbox"/> A copy of the Public Risk Insurance. The policy must be current and be for a minimum value of \$20 million dollars (\$20,000,000).</p> <p><input type="checkbox"/> Nominate relevant Category of work (Table 1 – Page 2) and provide detail description of work.</p> <p><input type="checkbox"/> Work commencement dates.</p> <p>PLEASE NOTE:</p> <ul style="list-style-type: none"> For Fencing/Hoarding plans, clear dimensions showing the length is required For Road Work/Occupation, clear dimensions showing the occupation zone is required. Where the works are a requirement of development consent, any relevant documentation as specified in the development consent and a copy of stamped approved plans. Where construction works are proposed, a copy of Council approved plans of the proposed works within the road reserve. Where work is required on an RMS Classified road, an ROL issued by the RMS may be required with your application. <p>This application may take up to five (5) working days to process and is subject to the applicant providing all the relevant information as it relates to the proposed works.</p> <p>If your application involves a complete road closure, approval from the Traffic Committee is also required prior to obtaining this consent. Please call Customer Service on 4227 7111 for any enquiries.</p> <p>You are advised that your application will be refused unless all the required information is lodged with the application form.</p>
